- A Member desiring to exercise its/his/her vote by Postal Ballot may complete this Postal Ballot Form and send it to the Scrutinizer in the enclosed self-addressed postage pre-paid Business Reply Envelope. Envelopes containing Postal Ballot Form, if deposited in person or sent by courier or any other mode at the expense of the Member(s) will also be accepted.
- 2. Postal Ballot Form should be completed and signed by the Member as per the specimen signature registered with the Company/ Registrar & Transfer Agent/ Depository Participants, in respect of shares held in physical form or dematerialized form respectively. In case of joint holding, this Form should be completed and signed by the first named Member and in his / her absence, by the next named Member.
- 3. In case of shares held by companies, trusts, societies etc., the duly completed Postal Ballot Form should be accompanied by a certified true copy of Board Resolution/authorization giving requisite authority to the person voting on the Postal Ballot Form together with duly attested specimen signature (s) of the authorized signatories. Where the form has been signed by a representative of the President of India or of the Governor of a State, a certified copy of the nomination should accompany the Postal Ballot Form.
- 4. The consent must be accorded by recording the assent in the Column 'FOR' and dissent in the column 'AGAINST' by placing a tick mark (✓) in the appropriate column.

However, the duly filled in duplicate Postal Ballot Form should reach the Scrutinizer not later than the close of working hours at 5.00 p.m. IST on 31st January, 2023. - 8. The right of voting by Postal Ballot shall not be exercised by proxy.
- 9. Members are requested to fill the Postal Ballot Form in indelible ink (and avoid filling it by using erasable writing mediums like pencil).
- 10. Voting rights shall be reckoned on the paid up value of the shares registered in the name(s) of the Member(s) on the **cut-off date i.e.** 23rd December, 2022.
- 11. Unsigned, incomplete or incorrectly ticked Postal Ballot Forms shall be rejected.
- 12. Members are requested not to send any other paper along with the Postal Ballot Form in the enclosed self-addressed postage prepaid envelope. If any extraneous paper is found, the same will be destroyed by the Scrutinizer.
- 13. There will be one Postal Ballot Form for every Folio/Client ID, irrespective of the number of Joint holders.
- 14. The Scrutinizer's decision on the validity of Postal Ballot Forms shall be final.
- 15. The Company is pleased to offer remote e-voting facility as an alternative, for all the Members of the Company, to enable them to cast their votes electronically instead of dispatching Postal Ballot Form. E-voting is optional. The detailed procedure of e-voting is enumerated in the Notes to the Postal Ballot Notice.
- 16. The results of the Postal Ballot shall be announced on or before 2nd February, 2023 at the Registered Office of the Company as specified in the Postal Ballot Notice.
